#### **FACT SHEET 2023**

<u>The Military Officers Association of America</u> (MOAA) is the nation's largest and most influential association of military officers. It is an independent, nonprofit, politically nonpartisan organization.

The Falcons Landing Chapter (FLC) is one of more than 400-plus local organizations affiliated with National MOAA and is a member of the Virginia Council of Chapters. The Chapter is located at Falcons Landing, a Military Life Community which is operated by the Air Force Retired Officers Community (AFROC). It is the only MOAA Chapter in Loudoun County. The Chapter is also a member of the Virginia Council of Chapters, MOAA

The mission of the Chapter is to provide programs to support: those who are serving; those who have served; and those who have survived, while placing special focus on community support.

Chapter membership is open to those who hold, or have ever held, a warrant or commission in any component of the Army, Marine Corps, Navy, Air Force, Coast Guard, Space Force, Public Health Service, NOAA, and their surviving spouses.

As of December 2022, there are 127 Premium Members and 85 Auxiliary Chapter Members.

The most significant, ongoing program for the Chapter is the multifaceted local support to veterans and their families. The Chapter established the *Loudoun Veterans and Family Support (LVFS)* program in partnership with Community Lutheran Church of Sterling, providing financial and general support to Loudoun County Veterans needing assistance.

The Chapter strongly supports the <u>Loudoun County Community Veterans</u> <u>Engagement Board</u> (LCCVEB), whose purpose is promoting a healthy and enriched lifestyle for Loudoun County veterans and their family members through community outreach and advocacy on Loudoun County veterans' issues.

The Chapter sponsors the *Gathering*, a program of distinguished guest speakers for monthly presentations on current and past world and government affairs.

The Chapter has established a *Speakers' Bureau*. This initiative is in keeping with the chapter's goal of continuing to inform the American public about their military establishment. There are currently 16 topics and speakers available for presentation to the local community.

Four times a year the Chapter supports the *AdoptaPlatoon Soldier Support Effort*® dedicated to serving deployed United States Service Men and Women by providing ongoing care packages to improve quality of life and raising morale for those serving overseas in the Army, Air Force, Navy, Marine Corp, Coast Guard and Special Forces.

The Chapter supports three *Junior ROTC* units in our area of responsibility: the Air Force JROTC unit at Chantilly High School in Fairfax, the Navy JROTC unit at Loudoun County High School in Leesburg, and the Army JROTC unit at South Lakes High School in Reston. The Chapter President and Director of JROTC Programs present scholarships to selected cadets at each school. In addition, the Lieutenant General John Pustay Scholarship is awarded to a selected cadet at Chantilly High School.

Memorial and Veterans Day Programs are presented each year at Falcons Landing.

The probability of favorable legislative action is in direct proportion to the number of voters who register support. MOAA sometimes includes postcards and letters in its magazine (Military Officer) for us to sign and mail to our representatives (identified for us). The MOAA Newsletter may also include an online access to act. It is imperative that we do so. To access the MOAA Newsletter go to the MOAA website at www.moaa.org and select the News and Info tab, followed by selecting Newsletters.

The MOAA Newsletter "is an award-winning member-only enewsletter subscription to provide information on topics most important to you. Whether you're looking for updates on current legislative issues, want to know more about your military benefits, or just interested in the latest MOAA events, you can tailor your newsletter to align with your specific needs and interests." It is included with your MOAA membership. If you are not registered with MOAA National for this, call the front desk (800) 234-6622, and you'll be guided on how to receive the newsletter on a desired schedule. Our Chapter periodically publishes Legislative Updates for all members and works with MOAA to recommend to members that they support MOAA legislative initiatives by contacting their legislators. MOAA staff and Chapter members meet with members of Congress annually. # SUPPORT THE MOAA LEGISLATIVE PROGRAM JIM MULLEN

You have the opportunity to support MOAA now! MOAA has identified several key initiatives to support the military family by responding to our legislative representatives and senators asking for their support with legislation. Three of these initiatives directly impact veterans. By visiting the MOAA website (MOAA.com) you can register with the MOAA advocacy program and then elect to forward a letter of support from the MOAA website. Three items to review:

### **Urge Your Legislators to Support Concurrent Receipt**

It's the start of a new Congress, and any legislation not signed into law during the previous Congress will need to be reintroduced. So contact your representative and senators and urge them to support the Major Richard Star Act, which would authorize combat-injured veterans to receive their full DoD retirement pay earned for years of service and their full VA disability compensation for lifelong injury.

### Ask Your House Member to Support the Expanding America's National Cemetery Act

A long-term legislative solution will preserve burial with military honors for countless elderly and women veterans who could lose that earned benefit – but only if MOAA members and others encourage their lawmakers to act. Outreach to your House member will help improve the chances for the Expanding America's National Cemetery Act (H.R. 1413) to be either enacted as standalone legislation or be included in the FY 2024 NDAA.

### **Tell Congress You Oppose TRICARE for Life Fees**

A recent Congressional Budget Office report includes two proposals among its options to cut the deficit that would increase costs for seniors using the TRICARE for Life (TFL) benefit. Although these are just concepts, not legislation, it's important to let Congress know we strongly oppose any plans to reduce the earned TFL benefit.

### HELP SUPPORT OUR CHAPTER PROGRAMS

Our activities, especially the veterans' assistance and scholarship programs, require funds well beyond our annual dues. Last year, we solicited donations, and your response was generous. Again, we are asking for your support, promising to apply your donation as you designate. Please annotate your check on the memo line: "veterans assistance," "scholarships," "Adopt-A-Platoon," or "general" (meaning expenses consistent with our mission). Checks should be made out to the "Falcons Landing Chapter of MOAA" and placed in the mail slot of our Treasurer, Tom Owens, 46916. Those outside Falcons Landing may mail to Tom at the address in our letterhead. Your contributions may be tax deductible on your federal return. We will send all donors a thank-you letter to that effect.

# **JROTC SCHOLARSHIPS FOR 2023**



On December 1, 2022, the Falcons Landing Chapter of MOAA Board agreed to award two \$500 JROTC scholarships in honor of our two WWII veterans recently recognized at the 2022 Veterans Day ceremony. The Colonel Herb Stern, USA (Ret) Scholarship will be presented to an Army Junior ROTC cadet at South Lakes High School and the Captain Dale Reed, USN (Ret) Scholarship will be presented to a Navy Junior ROTC cadet at Loudoun County High School. The scholarships will be presented in May at an awards ceremony at each high school.

With the recent decision by the board to support the AJROTC program at South Lakes High School, the Falcons Landing Chapter will be supporting the AFJROTC at Chantilly High School, the NJROTC at Loudoun County High School, and the AJROTC at South Lakes High School. A total of nine JROTC scholarships will be presented in 2023.

# GATHERING: THE COLD WAR PRESENTATION

- The speakers from the Cold War Museum at Vint Hill Farms were the museum Executive Director, Jason Hall and Mike Washville, a museum docent and veteran who had previously served in the military at Vint Hill. As the program announcement said, many of us had direct experience with events of the Cold War, whether as a military veteran or family member. Beginning in WWII, Vint Hill Farms Station (VHFS), located in Fauquier County, VA, near Warrenton, served as a signals intelligence and electronic warfare center for the United States Army and National Security Agency (NSA). During WWII, Vint Hill Farms served as an important intelligence gathering station intercepting message from various Japanese and German headquarters and forces and, for example, providing significant information that contributed to the successful D-Day invasion. After the war, VHFS became a field station of the Army Security Agency conducting signals intercept and serving as a training center for radio-intercept operators, crypto-analysts and radio-repair technicians. VHFS later served as the Army Electronic Material Readiness Activity and provided signals intelligence and electronic warfare systems maintenance for electronic warfare units worldwide.
- As the military force structure changed, VHFS was finally closed in 1997 (after some 50 years). Today the area has several commercial ventures plus the Cold War Museum, which provides an excellent representation for the many intelligence related episodes of the Cold War in a very realistic setting. For our evening, we were able to share some of these events with our speaker and to add a few extra stories from our own residents.
- Jason Hall opened with a discussion of "Five Eyes"—the close working relationship between the United States, the United Kingdom, Canada, Australia and New Zealand—looking back to the early days of WWII and the formation of the OSS.



# GATHERING: THE COLD WAR PRESENTATION (cont)

- The close working arrangement allowed some highly classified exchanges of intelligence information and in some cases provided an advantageof some HUMINT contacts that were critical to the resolution of events.
- Jason then provided us with several case studies from the Cold War. The special topics he discussed focused on the Cuban Missile Crisis, Project Able Archer and the Moscow Rules, with the opportunity to provide some inside consideration of these events.
- Of the three events the Cuban Missile Crisis had to be one most familiar to all of us as we were, so to speak, quite nearby. It was an example of a Nuclear Close Call. The Russians had installed missile silos in Cuba and were in the process of shipping missiles for the silos and the US response was to announce a quarantine (polite word for blockade). One factor in our advantage came from HUMINT intelligence sources in Russia provided by the UK that provided deep insight into Russian intentions and the fact that Russia did not have sufficient missiles to launch what appeared to be the major risk. Knowing that fact changed the situation and our response options. Jason went on to discuss the situation in more detail and discussed some activity that occurred in the Cuban blockade area that could have escalated into combat except for the action of a highly placed Russian naval officer, Vasiuli Arkhipov, stationed with the Soviet

submarine fleet, who was able to defuse a potential violent escalation. (As Jason said, you need to read about the Arkhipov incident for further details, but since we are still here in one piece we know that all turned out well—or better yet you should plan to visit the Cold War Museum!).

• The second incident relates to Project Able Archer, which was an annual NATO military exercise (let's call it Reforger) that involved thousands of military personnel and equipment. The goal of the exercise was to simulate an escalation in a conflict between NATO countries and the USSR, culminating in a coordinated nuclear attack.



# GATHERING: THE COLD WAR PRESENTATION (cont)

- Obviously both sides became involved with realism. We did too good a job and the Soviets were prepared for a possible real response. It was a HUMINT report from a Soviet source that averted the situation, although when the report reached the UK and the US, the US was skeptical. It would be some time before the extent of the Soviet war scare would become apparent to U.S. Intelligence officers. Despite defector Oleg Gordievsky (HUMINT) informing both MI6 and the C.I.A., it was only the former who believed him. After being briefed, Margaret Thatcher ordered her officials to "urgently consider how to approach the Americans on the question of possible Soviet misapprehensions about a surprise NATO attack," according to Unredacted.
- Well, you need to go to the museum or read the research on Able Archer for details but obviously we managed to get out of the situation, since we are still here and the Soviets calmed down. That leads to the third situation: The Moscow Rules.
- I thought I would add an item from a news article in 2021 and suggest that you find an opportunity to visit the Vint Hill Farms Cold War Museum for details on the Moscow Rules (from the author). "Nearly anyone can be labeled a 'foreign agent. One of Russia's newly adopted "foreign agent" laws allows for this label to be applied to ordinary citizens and unregistered organizations that are involved in politics in Russia (broadly defined) and receive assistance from other countries. The other law outlines punishments of up to five years in prison for potential foreign agents who do not register their status themselves or foreign agents who fail to report on their activities. This law has already come into force.
- The rest of the evening involved a spirited Q&A session with discussion between the audience and our guests. Thanks to our Falcons Landing chair for the evening Linda Childs who let us know that she planned to take some family members to the Cold war Museum that very week.
- Oh! And perhaps you might also plan to attend the next Gathering in person instead of through channel 970 because, you know we do have plenty of cookies.

- CHOOSE A FUNERAL HOME AND MAKE BURIAL ARRANGEMENTS.
- SUBMIT THE SURVIVOR BENEFIT PLAN FORM, IF APPLICABLE.
- REVIEW INSURANCE POLICIES.
- CLOSE OUT MEDICAL AND DENTAL RECORDS, AND FILE TRICARE AND MEDICARE CLAIMS, IF APPLICABLE.
- REVIEW ALL LEGAL DOCUMENTS, INCLUDING WILLS AND TRUSTS.
- COLLECT DEBTS OWED TO THE DECEASED.
- OBTAIN ADVICE ON JOINT FINANCIAL ACCOUNTS AND RETIREES' CREDIT CARD ACCOUNTS. UPDATE FINANCIAL ACCOUNTS.
- NOTIFY CREDIT BUREAUS OF THE DEATH.

- CHANGE OWNERSHIP OF JOINT ASSETS AND ACCOUNTS.
- FILE INSURANCE CLAIMS AND REVIEW INSURANCE FOR COVERAGE.
- REVIEW AND UPDATE SUPPLEMENTAL HEALTH INSURANCE.
- RETURN SPOUSE'S ID TO AN ID CARD OFFICE WITH DEATH CERTIFICATE.
- GET SURVIVOR'S ID CARD IF NEEDED.
- CONTACT SOCIAL SECURITY AMINISTRATION.
